David has developed particular expertise helping businesses navigate Internet, software, and Internet Corporation for Assigned Names and Numbers (ICANN) issues, and assists clients with the often novel application of intellectual property claims to cyber scams, intangible thefts, social media issues, and other Internet and software based disputes. He is the author of Bloomberg BNA's *Guide to the Anticybersquatting Consumer Protection Act* and, in each of the past few years, represented clients in more than double the number of *in rem* anti-cybersquatting lawsuits than the closest competing firm – with hundreds of domain names and websites at issue.
